

Case Study: Leading the delivery of the Greener NHS Programme across Cheshire and Merseyside

Project status: Ongoing appointment

Timescales: Two year embedded role, 2021-2023

Services provided: gbpartnerships are providing an embedded role to lead on the delivery of the Greener NHS Programme

gbpartnerships' (gbp) dedicated and expert team is working in partnership with Cheshire and Merseyside (C&M) Integrated Care Board (ICB) and Integrated Care System (ICS) to embed a governance framework, developing processes to enable the delivery of the C&M's Green Plan, with a focus on Social Value and reducing health inequalities.

This work is being delivered by gbp through a long-term embedded role within C&M ICB/ICS. With the system benefitting from gbp's expertise, flexibility and links to central and national policy.



Our Role:

- gbp are working in a long-term partnership with delivery of an embedded role for Cheshire and Merseyside ICB, with key deadlines to be met throughout this time.
- gbp's embedded role has focused on creating a system wide governance process, aligned with individual organisation processes and priorities and can be delivered at Place.
- This has a focus on relationship management, as well as delivering on specific initiatives. It is a wide ranging and eclectic role that is really helping to make a difference across Cheshire and Merseyside ICB and ICS.



Impact:

- This work has helped to create structure and purpose for the Greener NHS and Social Value work across Cheshire and Merseyside.
- As a result of gbp's work, the Green Plan has been written and successfully adopted, with the identified priorities now being delivered on.
- This is a long term piece of work, that will embed new ways of working and change behaviours.
- In particular, the implementation of the Cheshire and Merseyside Anchor Framework, led by gbp in the embedded role and adopted by the ICB, will change people's lives in years to come. The Framework has a number of priorities including a commitment to net carbon zero and a commitment to paying the real living wage.
