Embedded Project Management Services at Crawley Hospital

Ensuring NHS estate buildings are continually fit for purpose



Client: NHS Property Services

Timescales: Ongoing

Services provided: Embedded Project Management services are provided by gbpartnerships, on behalf of NHS Property Services, delivering ongoing hospital improvement and compliance projects.

Crawley Hospital is the principal hospital within the local area. The site is conveniently located near Crawley town centre. Surrey and Sussex Healthcare NHS Trust and Sussex Community Foundation Trust provide several services (inpatient, outpatient, community and primary healthcare services) at the hospital.

gbp manage have been involved with the delivery of embedded Project Management Services at Crawley Hospital for many years. As a key service provider to the local area LIFTCo, West Sussex Estates Partnership, the expert team have been employed by NHS Property Services to maintain an on-site team to undertake project management and employer's agent roles.

The gbp team are integral to the delivery of ongoing hospital improvement and compliance projects. Responsibilities of the team include:

- Appointing and managing design teams
- Reviewing scope of works and feasibility plans
- Overseeing tender processes, awarding and managing contracts
- Project managing construction works on behalf of the client
- Cashflow management
- Liaison with operational users



Project Examples:

- **Sub-Acute Ward:**
 - Construction of Piper Ward, a sub-acute ward for Crawley and the surrounding areas. Providing a step up / step down setting for patients who are not well enough to be discharged to home, but do not need to be in an acute setting.
- **Yellow Wing Compliance, Phase 1 and Phase 2:**
 - Landlord compliance works to bring the Yellow Wing up-to-date with current compliance regs for fire, water, electricity and medical gas.
 - Construction of Viking and Caravelle Wards, full compliant refurbishment.
- **Yellow Wing Plant Room Refurb:**
 - Landlord compliance works.
- **Red Wing Theatres Electrical Compliance:**
 - Landlord compliance works, bringing the Theatres up-to-date with electrical compliance regs.
- **Lift Refurbishment:**
 - Refurbishment of the public lifts in the Red Wing to up-to-date with compliance regs.
 - Refurbishment to the public lifts in the Yellow Wing to bring them up-to-date with compliance regs.
- **Link Bridge Refurbishment:**
 - To remove RAAC and make safe the bridge linking the Red Wing to the Yellow Wing.
- **Fully reconfigured floor of the Yellow Wing to create a new Child Development Centre:**

Case Study

Crawley Hospital, Child Development Centre

Project: Child Development Centre at Crawley Hospital

The local health system had long recognised that current accommodation for Child Development Services at Crawley Hospital was no longer suitable. This coupled with substantial increase in the demand for services meant that plans were put in place to develop an alternative facility.

gbp manage assessed various options for the provision of a new Child Development Centre (CDC), culminating in a fully reconfigured floor of the Yellow Wing of Crawley Hospital.

The project is part of NHS Property Services Healthy Places Programme, and the new space provides dedicated, modern, fit-for-purpose accommodation, supporting the delivery of integrated services to more of the local population, reducing waiting times and the need for multiple appointments.



Our Role:

gbp manage have been involved with the estate management of Crawley Hospital for many years. As a key service provider to West Sussex Estates Partnership, the local area LIFTCo, the team were well placed to deliver this important project. gbp manage and gbp consult teams were appointed through the LIFTCo by NHS Property Services to:

- Assess potential options for a new CDC within the existing Crawley Hospital site.
- Develop the Outline Business Case and Full Business Case through to approval from NHS England / NHS Improvement.
- Project manage the Design Team and preparation of the tender specification.
- Project manage the construction delivery and commissioning of the new CDC.
